INFORMATION AND CONDITIONS FOR ADMISSION

- (1) Nischai Academy for Judicial Services shall admit 40 Sikh students to its course starting on 15-07-2024.
- (2) Classes shall be held at the Panth Rattan Jathedar Gurcharan Singh Tohra Institute of Advanced Studies in Sikhism, Bahadurgarh, Patiala.
- (3) The admitted candidates requiring hostel accommodation will be provided free boarding, lodging and mess facilities.
- (4) The candidates desirous of taking admission can apply online through prescribed form available at www.desgpc.org with registration fees of Rs. 500/-
- (5) The candidate must have passed B.A.,LL.B. five year Course or LL.B. three year course from a recognised University and enrolled or eligible to be enrolled as an advocate under the Advocates Act, 1961. The candidate must be eligible to appear in the in the Judicial Services Competitive Examination conducted by the Punjab Public Services Commission.
However, the candidates who are appearing in the final examination of the graduation course in law i.e. from a recognised university in the current academic session may also apply provisionally subject to fulfillment of eligibility not later than 10.07.2024
- (6) The admission to the Nischai Academy for Judicial Services shall be made on the basis of merit drawn as under :
 - (1) 75% weightage to the percentage score in the entrance test.
 - (2) 10% weightage to written English Essay Test.
 - (3) 15% weightage shall be given to the interview performance.
 - (4) In case of equal score in the merit drawn as above the candidate who has higher percentage of marks in the qualifying examination shall be given preference. In case the candidates have same percentage of marks in the qualifying examination the candidate elder in age shall be considered.

Note :

Candidate should not be Patit. Baptised Sikh (Amritdhari) candidates will be preferred.

Instructions for Entrance Test and its Syllabus

1. The Entrance Test shall be of Objective Type. Duration of the Entrance shall be of two hours.
2. **The Entrance test shall be in two parts.**
 - (1) Basic Knowledge of Sikh Religion (Paper-I Qualifying paper only)
 - (2) Law Subjects and General Knowledge and Current Affairs (Paper-II)
3. The Entrance test shall be conducted in a single sitting. In the first fifteen minutes the candidates shall answer **20** questions on Sikh Religion in separate booklet. In the remaining one hour forty five minutes candidates are to answer **100** questions on various subjects of, General Knowledge and Current Affairs in another booklet.
4. Each objective type question shall be of **three** marks. There shall be negative marking. For each wrong answer 0.5 marks shall be deducted.
5. The qualifying marks for paper on Religion shall be 50%. Every candidate must qualify the religion (Paper-I) to be eligible for admission. Those who would fail to secure 50% in Paper – I, their candidature shall be cancelled.

6. Admission Criteria:

The admission to the Nishchey Judicial Services Coaching Academy shall be made on the basis of merit drawn as under:

1. 75 % weightage to the percentage score in the (Paper-II) entrance test to be conducted by the Nishchey Judicial Services Coaching Academy.
2. 10% weightage to written English Essay Test to be conducted on the date of interview performance.
3. 15 % weightage shall be given to the interview score.
4. Final Merit shall be drawn out of 100 marks.
5. In case of equal score in the merit drawn as above the candidate who has higher percentage of marks in the qualifying examination (L.L.B. Professional/B.A.L.L.B) shall be given preference. In case the candidates have same percentage of marks in the qualifying examination the candidate elder in age shall be considered.

NOTE: All information regarding center of examination, Admit cards, Result of qualified candidates and final list of selected candidates shall be uploaded on the website (www.desgpc.org). Candidates are advised to visit the site for updating regularly. It is further informed that candidates are required to apply online only.

- Changes brought in Bharatiya Sakshya Adhinyam, 2023

(v) Constitutional Law:

- Fundamental principles of the Indian Constitution
- Structure and functions of the judiciary, executive, and legislative branches
- Fundamental rights, directive principles, and constitutional remedies

- Principles of contract formation, performance, and breach
- Types of contracts, essentials of a valid contract, and remedies for breach of contract
